

**Town Council**  
**Regular Meeting Minutes**  
**November 11, 2024**  
**6:00 PM**

The Town Council of the Town of Kouts, Indiana met in the Kouts Town Hall, 210 South Main Street, Kouts, Indiana 46347 on the 11<sup>th</sup> day of November at 6:00 p.m. for the purpose of conducting their regular monthly meeting.


**Adjournment**




