Rental fees and deposit are due at the time of reservation. All Rental Permit fees shall be non-refundable if the permit is not canceled by the applicant 90 days in advance for which the permit was issued.

The deposit fee will be refunded within 30 days after the rental date, providing all keys have been returned to the Town Hall, all trash (from cans, gazebo, bathrooms, etc.) should be placed in the dumpster, and all bathrooms have been picked up. All deposit refunds may be adjusted at the Park Board's discretion to cover any damages or breach of contract.

The alcoholic beverage permit allows the holder and his or her party to bring alcoholic beverages onto property owned and operated by the Town of Kouts. The permit allows only the possession of alcoholic beverages by adults, 21 yrs of age and older. The permit is not a license to sell such beverages. All paid alcohol permits will be on file with the Kouts Town Hall and the Kouts Police Dept.

**KEYS:** Keys for water and electric usage must be picked up prior to reservation date and returned the next business day after use to the Town Hall Mon-Fri 8:00am-4:00pm. If you have any questions, please contact Town Hall at (219) 766-3312.

<u>OTHER:</u> Note the playground equipment and dog parks are open to the public. Park rental is from 7:00am-9:00pm. Bathrooms are open from 8am-8pm. No bounce houses or other play equipment are allowed without proper insurance provided to the Kouts Town Hall at time of rental.
