

## Ordinance 2025-4 Miscellaneous Fees Ordinance

**BE IT ORDAINED**, by the Town Council of the Town of Kouts, Indiana, that Ordinance No. 2025-4 Miscellaneous Fees dated March 10, 2025 is hereby amended to read as follows;

**24.01 Miscellaneous Fees.** The Clerk-Treasurer shall charge and collect a fee for the following:

Commercial and institutional fees are based on service size and will be determined on a case-by-case basis, based on the size of the connection and meter as well as the complexity of the installation. Larger than 1” meter prices vary by size.

Meter connection parts are additional to the connection fee and are also based on service size and current rates or costs.

**NOW THEREFORE, BE IT FURTHER ORDAINED**, that any and all such Ordinances or parts of Ordinances of the Town of Kouts that are in conflict with the provisions of this Ordinance are hereby repealed and of no further force or effect.

**NOW THEREFORE, BE IT FURTHER ORDAINED**, that this Ordinance shall be in full force and effect from and after its passage and posting according to law.




